WHEREAS, a Pre-Bid Conference was held on September November 26,2018 at 10:00am at the Training Room of San Lorenzo Ruiz Women's Hospital with one (1) prospective bidder who attended namely; **NISSAN COMMONWEALTH INC;**

WHEREAS, a Bid Bulletin no. 09 was issued dated November 29,2018 a

WHEREAS, the deadline of submission and opening of bids is on December 10,2018 at 10:00am, at SLRWH Training room

WHEREAS, 1 prospective bidder namely **NISSAN COMMONWEALTH INC** procured the bidding documents and submitted its Bidding proposal;

WHEREAS, the first envelope containing the eligibility and Technical Documents was opened. The presence, completeness and correctness of the required documents was checked and verified by the HBAC in the presence of the prospective bidder's representative after which all prospective bidders were declared "ELIGIBLE";

WHEREAS, the second envelope, containing the Financial Documents, was opened, the presence, completeness and correctness of all the documents was checked and verified by the HBAC, upon examination, all ELIGIBLE bidders were rated "PASSED". Subsequently, their bid proposal was read and posted in the Abstract of Bids;(see attached Abstract of Bid)

WHEREAS, NISSAN COMMONWEALTH INC. was the lone Bidder for item no. **1** .(LAND AMBULANCE) and was found complying.

WHEREAS, No bid was received for item no 2 (Motorcycle).
